

1. Pool play is two sets to 21 or 25, no cap, must win by two points.
2. Warm ups are in the 2 - 4 - 4 format with serving included in your 4 minutes for each team's first match of the day. Reminder: no shared hitting.
3. After each team has first match, the next match warm up will immediately follow with the 1 - 3 - 3 format. Coaches must be sure to keep the tournament on time.
4. The carpet is NOT the playing surface. Players MUST start on sport court when starting serve.
5. All material above the court is played as the ceiling.
6. All fan seating is to be OFF of the carpeted area. This includes NOT placing feet, bottles, etc on the court.
7. All team camps should be in the concession area using the tables. Be sure to CLEAN the area BEFORE your team leaves. Fines will be assessed to the teams that fail to clean their camp area. Thank you for using the trash cans.
8. Teams are to CLEAN the bench areas immediately after their match.
9. EVERYONE is responsible for their officiating duties.
10. Fans are encouraged to bring lawn chairs as there are no bleachers.
11. There WILL be a concession. NO COOLERS in the facility.
12. WE WILL HAVE CONCESSIONS. NO FOOD OR DRINK IS TO BE BROUGHT INTO THE FACILITY.
13. Parking is at a premium. You may park behind our building, across the street at the Cotton Gallery or at the south end of our building.

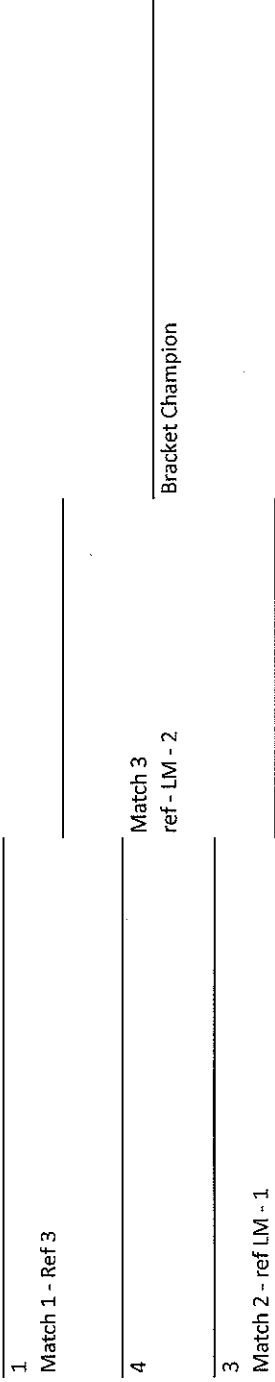
At the completion of round 6 teams will be placed in brackets below based on the following:

Sets Won. Point differential. Flip of a coin.

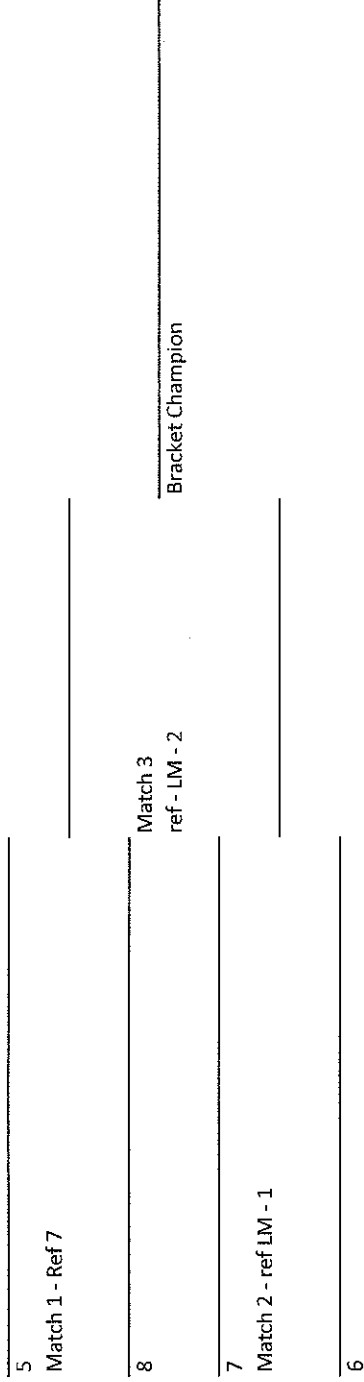
All brackets will receive 1st place medals. Nobody goes home. No playoff/play-in matches. EVERY POINT COUNTS.
